- 1999 National Reconciliation Programme (NRP)
- 2001 Ethnic Nationalities Solidarity & Cooperation Committee (ENSCC)
- 2004 Ethnic Nationalities Council (ENC)
- 2010 Committee for the Emergence of a Federal Union (CEFU)
- 2011 Common Ground initiative: ENC & United Nationalities Federal Council (UNFC)
- 2012 Ethnic Peace Plan & Working Group for Ethnic Coordination (WGEC)
- 2013 Nationwide Ceasefire Coordinating Committee (NCCT)

#### Analysis RCSS & UNFC

- Undertook armed struggle because Constitutional Right was denied (1958)
- Shan sought a political solution (Federalism 1960)
- Did not join NDF (1978), ENSCC (2001), ENC (2004), CEFU (2010), UNFC (2011) or NCCT (2013) because the alliances did not respect Federal principles state-based.
- Cooperated with ENSCC, ENC, NCCT as observers
- 2011 ceasefire negotiations to seek a political solution

## Analysis KNU & UNFC

- Karens sought a political solution (Karen State)
- Armed struggle was a defensive reaction (1949)
- NRP (1999) was an attempt to bring the struggle back to the political arena
- 2010 CEFU with KNU-KIO participation (political)
- 2011 UNFC focussed on military solution / Federal Army
- 2012 KNU ceasefire negotiations to seek a political solution



UNFC Chairman can make decisions without consulting Chairs of member organizations or their Executive Committees

UNFC Chairman can also make decisions without consulting the UNFC Executive Committee.

UNFC Executive Committee members cannot be changed by the Executive of member organizations.

# Analysis UNFC's Influence on Negotiations

"Signing NCA and starting a political dialogue with the current government is like voting for the USDP. We should only have a political dialogue with the NLD after the 2015 elections."

Analysis:

- 1. There is no guarantee who will win the elections,
- 2. Even if NLD wins there is no guarantee DASSK will be President,
- 3. Even if DASSK become President, there is no guarantee she will continue with the political dialogue,
- 4. Even if she continues with the dialogue, there is no guarantee she will offer something better,
- 5. Even if she offers something better, there is no guarantee she can control the Army.

## **UNFC** Decisions Affecting Unity

- 2011 No ceasefire negotiations.
- May 2013 No Joint-Negotiating Team.
- October 2013 No Joint-Decision-making body. NCCT formed instead.
- July 2013 No Joint Steering Committee. UNFC will lead.
- KNU proposal to reform UNFC Constitution rejected.
- NCCT must conform to UNFC decision & policy.
