RESULTS OF 1 APRIL BY-ELECTION HELD IN NAY PYI TAW, REGIONS AND STATES

The by-elections for 37 vacant seats in the Pyithu Hluttaw (*Lower House*), 6 vacant seats in the Amyotha Hluttaw (*Upper House*) and 2 Region/State Hluttaw seats, totalling 45 parliamentary seats were held in the regions and states, including Nay Pyi Taw, on 1 April 2012. In Nay Pyi Taw, over 165,000 eligible voters cast ballots at 36 polling stations in Zabuthiri Township, 49 polling stations in Ottarathiri Township, 17 polling stations in Dekkhinathiri Township and 81 polling stations in Pobbathiri Township.¹

Approximately 156 diplomats and international observers, and 137 foreign correspondents were also given the opportunity to observe the by-elections in there and in other parts of the country under the arrangement of the Ministry of Foreign Affairs and Ministry of Information. Similarly, up to 31 March the Ministry of Information had issued approval for 427 journalists and reporters from domestic journals to cover the election news.²

The Union Election Commission's declared the results of the by-elections through announcements No. 17/2012, No.18/2012, No. 19/2012, No. 20/2012 and No.21/2012 on 3 and 4 April 2012 in the New Light of Myanmar. According to the results, the National League for Democracy won 43 of 45 seats. The two remaining seats were won by the Shan Nationalities Democratic Party in Shan State Region Constituency No.3 and the Union Solidarity and Development Party candidate in Taninthayi Region Amyotha Hluttaw Constituency No.7. As one of the winning candidates, Aung San Suu Kyi will now represent Kawhmu constituency in Rangoon Region constituency as an elected MP of the Pyithu Hluttaw (Lower House) in the upcoming parliamentary sessions. KNU HOLDS HISTORIC PEACE TALKS WITH GOVERNMENT

The KNU held peace talks with the government's Union-Level Peace Making Group in Yangon on 6 April 2012. The two sides discussed the possibility of a long-term cease-fire, the opening of liaison offices as well as salient points raised by the KNU during the meeting held on 12 January 2012.⁴

The Karen National Union and the Burma Government delegations achieved 13 common positions in formalizing an initial historic ceasefire agreement between the two sides at their 'peace talks' held on 6 April, at the Sedona Hotel in Rangoon. After one day of negotiations, both sides agreed to adopt the principal of "progressive realization" and work towards a nationwide ceasefire, especially in the country's ethnic regions. The KNU and Burmese government said they had discussed, agreed and prepared a "ceasefire code of conduct" to guarantee security for the people. Both sides agreed to implement peace-building groups at a District, Township and Village-track levels. They also decided to establish local "Cease-fire Monitoring Groups" by the end of May 2012. Furthermore, an agreement was also reached to allow "international monitoring" on the progress of the cease-fire. Other decisions reached included plans to resettle and rehabilitate internally displaced people, on de-mining, on the resettlement of refugees, on citizenship accreditation, to implement a rule of law and working together towards "sustainable development", on land-right issues, on the participation of INGOs and local NGOs in the peace building process and on the release of all Karen political prisoners. As part of the agreement international observers and Karen leaders will also be allowed to observe the negotiation process.⁵

RAKHINE STATE LIBERATION PARTY/ARAKAN LIBERATION PARTY AND STATE GOVERNMENT PEACE-MAKING GROUP SIGN PEACE DEAL

The Rakhine State Government Peace-Making Group and the Rakhine State Liberation Party held peace talks from 4 to 5 April 2012 in Sittway and reached an agreement which contains the following points:

- a) The Tatmadaw and Rakhine State Liberation Party are to halt attacks on each other starting from 6 April 2012.
- b) To open liaison offices of Rakhine State Liberation Party at the following mutually agreed regions in order to ensure mutual contact and hold discussions:
 - 1) Paletwa
 - 2) Kyauktaw
- c) During the ceasefire, carrying weapons beyond the mutually agreed regions is to be coordinated in advance by both sides.
- d) During the ceasefire, members of Rakhine State Liberation Party are to be allowed to move freely without arms.
- e) Peace Making Group formed by the Union Government and Rakhine State Liberation Party are to continue their talks on peace and stability and development in mutually-agreed venues and times.

The Rakhine State government was led by Rakhine State Peace Discussion Group Minister of State Security and Border Affairs Col Htein Lin. The Rakhine State Liberation Party delegation was headed by Joint General Secretary-2 Khine Thukha.⁶

The Arakan Liberation Party (ALP) and the Rakhine State government signed a five-point peace deal on 5 April in the regional capital of Sittwe in an initiative to build peace between them. Khine Thukha, the Joint-General Secretary (2) of the ALP, and the second leader of the party's peace delegations, said that the five-point agreement was reached after two days of peace talks with the regional government. "We have signed the agreements to stop fighting each other, to open liaison offices in Kyauktaw and Paletwa for mutual communication, not to cross each others' areas holding weapons without prior information or negotiation, to allow members of the ALP free travel across the nation, and to continue negotiations for the activities to build peace and development inside Arakan State," he said. He added that the agreements would come into effect from 6 April. ALP Vice-President U Khine Soe Naing Aung added, "We presume this is the first step to solve the political problem by political means and hope that we will be able to make progress from this step as well".⁷

BURMESE PRESIDENT ATTENDS 20TH ASEAN SUMMIT

President U Thein Sein attended the opening of the 20th ASEAN Summit and the 45th Anniversary of the ASEAN in Phnom Penh, Cambodia on 4 April 2012.⁸ During the summit, President Thein Sein also attended the meeting between ASEAN Heads of State/Government and ASEAN Inter-Parliamentary Assembly, informal meetings between ASEAN leaders and representatives of ASEAN public organizations, and between ASEAN leaders and youth delegates on 3 April 2012.⁹ ASEAN leaders welcomed the successful holding of free and fair and transparent by-elections in Burma and unanimously supported the call for prompt lifting of economic sanctions on Burma.¹⁰

BURMESE PRESIDENT PAYS GOODWILL VISIT TO CAMBODIA

As part of his three-country tour, President Thein Sein arrived in Phnom Penh on 24 March for a 2-day state visit, during which he met King Norodom Sihamoni as well as Cambodian Prime Minister Hun Sen. In the official meetings, the Burmese and Cambodian leaders expressed that the two countries share the same religion, culture and customs and urged for the need to maintain friendly ties with future generations in mind. Furthermore, that it is crucial for both countries, both peoples and both governments to assist and cooperate with each other in economic, trade, investment and social affairs. The Cambodian PM also emphasized that links between the two countries should be expanded and that there are three points where links can be constructed—through the Mekong Bridge via Laos to Burma, through Vietnam to Burma, and through Thailand to Burma. Of these

countries, high-ranking officials, ASEAN Secretary-General Dr Surin Pitsuwan, and invited guests.

three, the 3rd route through Thailand to Burma is the shortest with the potential of becoming a link connecting India through East Asia.

The leaders also called for further cooperation at the regional level such as the Greater-Mekong Subregion (GMS) and the Ayeyawady-Chao Phraya-Mekong Economic Cooperation Strategy (ACMECS) while at the same time working to implement cooperation among ASEAN countries to establish "One vision, one identity, one community". ¹¹

PRESIDENT THEIN SEIN MAKES OFFICIAL VISIT TO LAOS

At the invitation of the Laotian President Choummaly Sayasone, Burmese President U Thein Sein arrived in Vientiane, Lao PDR on 22 March 2012. During the visit, Laos and Burma signed the agreement to build the "friendship bridge" across the Mekong River between the two countries to boost trade and investment. The leaders also agreed the need for continued friendship and collaboration in various fields. The Burmese President also met with the Prime Minister Thongsing Thammavong, the President of National Assembly Pany Tathortou and Lao-Myanmar Friendship Association Chairman Phanduongchit Vonsaon.¹²

MALAYSIAN PM VISITS BURMA

Malaysian Prime Minister Dato' Sri Mohd Najib Tun Razak arrived for an official visit to Burma on 28 March and met President Thein Sein for official talks, during which they held cordial discussions on further strengthening of existing friendship and economic cooperation between the two countries. The Malaysian Prime Minister called for the promotion of mutual relations as well as the establishment of a joint commission, and cooperation in the sectors of trade and investment, energy, education, banking, livestock and fisheries, agriculture, tourism and sports. The Burmese President also echoed the sentiments of the Malaysian Prime Minister and expressed his desire for the continued cooperation in affairs of Burmese workers in Malaysia and increased cooperation in trade, economic and investment sectors between the two countries. ¹³

A 3-member delegation led by Pyidaungsu Hluttaw Speaker U Khin Aung Myint arrived in Cambodia on 31 March to attend the preparatory meeting of the ASEAN Inter-Parliamentary Assembly (AIPA) Chairman and heads of Parliaments from member countries and the meeting of heads/leaders from ASEAN countries and delegates of AIPA at the 20th ASEAN Summit. On 2 April, the Speaker submitted a proposal on promoting the role of AIPA in ASEAN at the Preliminary coordination meeting between ASEAN Inter-Parliamentary Assembly (AIPA), which was attended by the AIPA Chairman and Chairman of The House of Representatives of Indonesia Dr Marzuki Alie, AIPA Secretary Mr Antonio V. Cuenco and AIPA representatives from ASEAN countries. The Speaker also attended the 20th ASEAN Summit and the opening of 45th ASEAN Anniversary Day, the meeting of heads/leaders from ASEAN countries and delegates of AIPA, as well as a dinner hosted by Chairman of National AIPA Group of Cambodia Dr Cheam Yeap.¹⁴

UPPER HOUSE SPEAKER RECEIVES GERMAN COMMISSIONER FOR HUMAN RIGHTS POLICY AND HUMANITARIAN AID

Amyotha Hluttaw Speaker U Khin Aung Myint received the Commissioner for Human Rights Policy and Humanitarian Aid of the German Ministry of Foreign Affairs Markus Michael Maria Loning on 28 March 2012. They exchanged views on human rights in Burma, the lifting of EU sanctions, Hluttaw affairs, on-going tasks of the development for Burma, by-election matters, the promotion of friendly ties between Burma and Germany as well as cooperation matters. Those present included Chairmen of the Amyotha Hluttaw Committee and officials of the Hluttaw Office. The German Commissioner also met the Union Minister for Border Affairs and for Myanma Industrial Development Lt-Gen Thein Htay and discussed promotion of bilateral ties between the two countries.¹⁵

Union Election Commission Chairman U Tin Aye received Director of the Asia and Pacific Division Department of Political Affairs of the UN Mission Tamrat Samuel on 31 March 2012. The UN mission arrived in the country to observe the by-elections on 1 April 2012. They cordially exchanged views on preparations for holding the by-election, canvassing of political parties and participation of the political parties in the by-election in line with the law. Those present included the UEC Secretary and officials.¹⁷

SHAN STATE ARMY-NORTH (SSA-N) TO HOLD UNION-LEVEL PEACE TALKS

The Shan State Army-North (SSA-N) has agreed to hold union-level peace talks with the government to solidify an initial truce made in January 2012. The group has agreed to embrace a federal union based on the historic Panglong agreement, which was led by independence hero General Aung San and brought together Shan, Chin and Kachin leaders to discuss autonomy in 1947. "We haven't set the time yet but we assume the government will propose a date," said spokesperson Sai La. Continued clashes between rebels and government forces have been reported since the initial truce was signed in January. Sai La said this could be due to miscommunication between military commanders and troops at the frontline.¹⁸

ANALYSIS

The results of the by-elections of 1 April reflected the desire and wishes of the people. The NLD won an overwhelming victory by taking 43 out of 45 seats. With international observers and members of diplomatic corps invited to monitor the elections, accusations and allegations of voter fraud and irregularities were limited. The government took all measures needed to conduct a free and fair election, and to a certain extent achieved its aim. The NLD will now need to live up to expectations as it takes its place in parliament. While winning the by-elections, the NLD still remains a minority and will therefore have to prove itself if it wants to become the leader of the opposition. One of the challenges that it will encounter is its relations with other democratic political parties.

The government in Nay Pyi Taw has once again defied expectations and kept its word in holding free and fair elections. We may be truly witnessing a new era in Burma.

The recent peace talks between the government and the KNU and the ALP are important and positive steps in the right direction. If only the government would come to terms with the Kachin Independence Organization in the north, peace may be finally achieved through dialogue and trust building.
